1. Scientific and Methodological Evaluation

Strengths

- Comprehensive empirical grounding: The use of multi-source datasets—UN DESA, World Bank, OECD, and national censuses—ensures exceptional breadth and reliability.
- Longitudinal approach: Covering 1850–2024 with reconstructed estimates contextualises migration within industrialisation, post-war reconstruction, and globalisation phases.
- Integration of qualitative and quantitative reasoning: Graphs (Figures 1–8) are consistent and visually persuasive; they effectively illustrate exponential growth of migrant stocks, remittance escalation, and demographic transition curves.
- Comparative analytical clarity: The U.S. policy chronology (Figure 7) and Brazilian post-abolition labour narrative form convincing case studies demonstrating causality between migration regimes and socioeconomic transformation.

Weaknesses / Areas for Improvement

- Methodological transparency: Although data sources are cited, the statistical harmonisation between historical estimates and modern datasets could be more explicitly explained (e.g., interpolation, adjustment for boundary changes).
- Analytical depth on econometric inference: The study remains descriptive; inclusion of at least basic regression or counterfactual estimation (e.g., GDP growth differentials with and without immigration) would strengthen causal claims.
- Temporal heterogeneity: The transition from historical to contemporary data introduces uneven granularity—nineteenth-century estimates are coarse compared with precise modern records. A short methodological appendix clarifying confidence intervals would be beneficial.
- Potential selection bias: Brazil's immigration experience is discussed with nuance, yet the role of internal migration (rural-urban and inter-regional) could have been briefly acknowledged to distinguish its effects from international inflows.

2. Structure, Clarity, and Scholarly Presentation

Organisation

The manuscript follows a classical structure—Introduction, Global Trends, Case Studies, Economic Impacts, Policy Evolution, Brazilian Experience, Demographic Challenges, and Conclusion. The transitions are smooth and cumulative, reflecting professional academic craftsmanship.

Clarity of Writing

The prose is elegant and consistently formal in the British academic register. Concepts are defined succinctly; paragraphs maintain coherence; and interpretative passages (e.g., Section 10) achieve commendable synthesis. Minor editorial corrections:

- Replace occasional Americanisms ("labor," "industrialization") with British spelling for stylistic uniformity.
- Simplify certain long sentences in the introduction to improve readability without diminishing gravitas.

Figures and Data Presentation

Charts are well-designed, legible, and colour-balanced.

- Figure 1 (p. 4): Effectively shows exponential growth with relative stability of migrant proportion. Figure 6 (p. 12): Demonstrates remittance expansion convincingly.
- Figure 8 (p. 20): Conveys humanitarian gravity but would benefit from distinguishing refugees and IDPs
- by shaded patterns rather than similar hues for accessibility. All figures include clear legends and sources—a mark of sound scholarly discipline.
